# 总干事的说明

截至 2014 年 7 月 31 日 《化学武器公约》第七条的履行现状综述

- 1. 缔约国大会(下称"大会")第十四届会议(2009年11月30日至12月4日)通过了一项关于"第七条义务国家执行措施"的决定(C-14/DEC.12,2009年12月4日),其中请技术秘书处(下称"技秘处"),除其他外,就《化学武器公约》(下称"《公约》")第七条的实施情况编写两份并行的年度报告,并请技秘处把这两份年度报告提交给执行理事会(下称"执理会")。请执理会审议这两份报告,并把报告酌情连同其建议一起提交大会。
- 2. 缔约国大会审查化学武器公约实施情况第三届特别会议(下称"第三届审议大会")"鼓励技秘处探讨提供量身定做的援助的创新性方法,作为进一步推进第七条实施的潜在途径。"<sup>1</sup>另外,请技秘处"继续向大会提交第七条实施情况年度报告······在该报告中列入一项包括对国家履约现状进行全面客观分析的评估,供决策机构审议,从而跟踪履约进展并制定有针对性的援助方案。"<sup>2</sup>
- 3. 本文对缔约国采取立法和行政措施以履行《公约》第七条规定义务的现状和进展作了综述,可作为两份有关缔约国采取步骤履行第七条义务的并行报告的引文,表明了全体缔约国所应采取的初步措施的现况以及拥有应宣布设施的缔约国所应采取的进一步措施的现况。
- 4. 本文的报告期为 2013 年 7 月 31 日至 2014 年 7 月 31 日,前一个日期是上两份提交执理会第七十四届会议和大会第十八届会议的年度报告(EC-74/DG.8 C-18/DG.10 以及 EC-74/DG.9 C-18/DG.11,同为 2013 年 8 月 28 日)的截止日期,后者是本文及前述两份报告的截止日期。总干事高兴地向执理会提交本文,作为《公约》第七条义务实施现况综述,供执理会审议并采取行动。

#### 国家主管部门的指定或设立

- 5. 根据《公约》第七条第 4 款,缔约国应指定或设立一个国家主管部门,作为本国与本组织和其他缔约国进行有效联络的中心。若是指定国家主管部门,指定一人作为联络人并向技秘处提供该人的详细联系资料即可满足通知要求。大会曾多次回顾这项义务的重要性并促请尚未做到这一点的缔约国指定或设立国家主管部门(C-14/DEC.12,第 1 段)。
- 6. 在报告期内,索马里和东帝汶都没有指定或任命国家主管部门。因此,尚未达到这一要求并需采取行动的缔约国的数目保持稳定为两个。<sup>3</sup>技秘处继续积极做这两个缔约国的工作,让它们设立或指定国家主管部门。
- 7. 至本报告期截止日,在业已指定或设立(常设或临时)国家主管部门的缔约国中,有8个表示正在调整或进一步发展国家主管部门,或者正在考虑今后进行此种调整或发展。据技秘处的观察,缔约国在继续深入研究国家主管部门和其他机构性安排的结构和运作方式,特别是在履约立法生效之后的结构和运作方式。

#### 第七条第5款提交: 概述

- 8. 根据第七条第 5 款,每一缔约国应将其为执行《公约》而采取的立法和行政措施告知技秘处。大会在 C-14/DEC.12 号决定中再次肯定了同一原则,有力地重申每一缔约国均有义务根据本国宪法程序,采取必要措施履行《公约》规定的义务,并敦请缔约国酌情不断向禁化武组织通报本国这方面正在采取的步骤(C-14/DEC.12,第1(b)分段)。
- 9. 报告期起始时,有 82 个<sup>4</sup>缔约国尚未采取必要步骤制订立法及(或)通过行政措施以充分履行《公约》第七条义务。报告期内,4 个缔约国,即格林纳达、密克罗尼西亚联邦、乌拉圭、也门,通知技秘处它们已采取措施并已覆盖所有初步措施(表 1)。因此,至报告截止日,尚有 78 个缔约国未向技秘处作已采取履约措施并已覆盖所有初步措施的通知。换言之, 112 个缔约国(59%)已通过了覆盖所有初步措施的立法和(或)行政措施。

10. 至报告截止日,3个在报告期起始时尚未通过覆盖初步措施的立法的缔约国,即黎巴嫩、密克罗尼西亚联邦和也门,作了首次第七条第5款规定的提交<sup>6</sup>(表2)。

- 11. 又有 12 个在本报告期以前曾作过第七条第 5 款提交的缔约国(即:阿尔巴尼亚、玻利维亚多民族国、巴西、保加利亚、厄瓜多尔、格林纳达、意大利、斯洛文尼亚、瑞士、塔吉克斯坦、美利坚合众国、乌拉圭)作了补充的第七条第 5 款提交(表 3)。可将这 12 个国家分类如下:
  - (a) 阿尔巴尼亚、玻利维亚多民族国、巴西、保加利亚、意大利、斯洛文尼亚、瑞士和美利坚合众国在本报告期开始时已有覆盖所有初步措施的立法。
  - (b) 格林纳达和乌拉圭在本报告期内通过了覆盖所有初步措施的立法。
  - (c) 厄瓜多尔和塔吉克斯坦尚未通过覆盖所有初步措施的立法。
- 12. 提交的这些资料包含 例如 对以前向技秘处报告过的履约立法的修订,履约立法文本,以及关于已通过了确保履约措施有效性的补充措施的通知。

13. 大会在 2003 年 10 月 24 日的 C-8/DEC.16 号决定中请缔约国向技秘处提供国家 履约立法的完整文本,其中应包含最新资料。在报告期内,格林纳达、密克罗尼西亚联邦、乌拉圭和也门提供了此类文本,使已提供国家履约立法完整文本的缔约国从 130 个增加到 133 个,占缔约国总数的 70%7。

### 第七条第5款提交:区域面貌

# 非洲缔约国(51)

14. 在报告期内,根据技秘处目前掌握的资料,19 个缔约国(以不同方式,例如电子邮件、普通照会、口头)向技秘处通报了它们所采取的旨在通过履约立法/规章的步骤(见图 1)。至报告截止日,尚未采取已覆盖初步措施的履约措施的缔约国均未通知技秘处它们通过了覆盖此类措施的立法。因此,根据技秘处掌握的资料,至本报告截止日(2014年7月31日),已制定覆盖所有初步措施的立法的非洲缔约国数目保持稳定,仍是21个(41%)。已通过覆盖部分初步措施的缔约国数目是8个(16%),尚未通过履约立法的缔约国数目是22个(43%)。换言之,有29个(57%)非洲缔约国已通过用以全部或部分履行《公约》的立法和(或)行政措施。


图 1: 报告期内向技秘处作了最新通报的缔约国

15. 图 2显示了截至 2014 年 7 月 31 日第七条第 5 款的提交状况。有 18 个缔约国 (35%)尚未作任何第七条第 5 款提交,其余 33 个缔约国 (65%)至少作过一次此种提交。在这 33 个缔约国中,21 个 (41%)已经制定了覆盖初步措施的立法,12 个 (24%)尚未有覆盖初步措施的立法。



16. 除了图 2 提供的数据,令人瞩目的是自 2003 年行动计划通过以来,第七条第 5 款提交(首次提交和补充提交)呈上升趋势。图 3 清楚地显示,2003 至 2009 年期间,提交数一直稳步增加。就首次提交(见图 3 的粗线)而言,2002 年作过首次第七条第 5 款提交的非洲缔约国只有 6 个(12%),而至本报告截止日,有 33 个非洲缔约国(65%)作了首次提交。换言之,自 2003 年行动计划启动以来,作过首次提交的缔约国数增加了 4 倍以上。同样值得注意的是,在 2011-2012 和 2012-2013 两个报告期观察到的上升趋势在上一报告期内(从 2013 年 7 月底至 2014 年 7 月底)平缓下来。只需几乎略作调整,对首次提交的走势的这种分析也适用于第七条第 5 款的补充提交的走势。

## 亚洲缔约国(52个)


17. 根据技秘处获得的资料,至报告截止日,22 个缔约国(以不同方式,例如电子邮件、普通照会、口头)向技秘处通报了它们所采取的旨在通过/修订履约立法/规章的步骤(见图 4)。


- 18. 应当注意的是在这 22 个缔约国中,有 3 个(即:黎巴嫩、密克罗尼西亚联邦和 也门)作出了本国首次第七条第 5 款提交(见表 2)。在报告期内,密克罗尼 西亚和也门通过了覆盖所有初步措施的立法,而黎巴嫩则尚未通过此种立法。
- 19. 因此,根据技秘处掌握的资料,至本报告截止日(2014年7月31日),已经制定覆盖初步措施的立法的亚洲缔约国数目增加至28个(54%),已通过覆盖部分初步措施的立法的缔约国数目为10个(19%),尚未通过履约立法的缔约国数目减少至14个(27%)。换言之,有38个(73%)亚洲缔约国已通过了全部或部分履行《公约》的立法和(或)行政措施。
- 20. 图 5显示了截至 2014 年 7 月 31 日的第七条第 5 款提交状况。重要的是应指出亚洲有 13 个缔约国(25%)尚未作任何第七条第 5 款提交,其余 39 个缔约国(75%)作了至少一次第七条第 5 款提交。

21. 图 6 显示了自 2003 年行动计划通过以来的第七条第 5 款提交走势。这是一种明显的上升趋势,但到 2010 年基本趋于平缓。在 2003 年至 2009 年间,无论是首次提交还是补充提交(尽管数量上有差异)均稳步上升,而且上升的速度也相似。从粗线(作过首次第七条第 5 款提交的缔约国数)来看,技秘处注意到2002 年作过首次第七条第 5 款提交的缔约国是 13 个(25%),而至本报告截止日(2014 年 7 月 31 日)39 个缔约国(75%)已作过首次提交。这就是说,自行动计划启动以来,作过首次提交的缔约国数增加到原来的 3 倍。这一趋势也同样适用于作补充提交的缔约国,其数量(同期)也有增加: 2002 年为 8 个(16%),而在本报告截止日则为 34 个(65%)。不过,重要的是应注意从2012 年起,已作出第七条第 5 款补充提交的缔约国的走势已趋平缓。

## 东欧缔约国(25个)


22. 根据现有资料,至报告截止日,有 14 个缔约国(以不同方式,例如电子邮件、信函、普通照会、口头)向技秘处通报了它们所采取的旨在通过/修订履约立法/规章的步骤(见图 7)。重要的是应注意到在这 14 个缔约国中,有 3 个(即:阿尔巴尼亚、保加利亚和斯洛文尼亚)在报告期起始时已经有了覆盖初步措施的立法,后又作了更新的第七条第 5 款提交(见表 3)。


- 23. 总的来说,至报告期终止时,在报告期起始时尚未通过覆盖初步措施的履约措施的缔约国中,无一通知技秘处其已通过了覆盖初步措施的履约措施。至本报告截止日(2014年7月31日),对照上年报告情况保持稳定。然而,须强调指出,其立法已覆盖初步措施的缔约国已数目可观。因此,根据技秘处掌握的资料,至本报告截止日(2014年7月31日),已经制定覆盖初步措施的立法的东欧缔约国数目保持稳定,仍然是23个(92%),已通过覆盖部分初步措施的立法的缔约国数目为1个(4%)。换言之,有24个东欧缔约国(98%)已通过了全部或部分履行《公约》的立法和(或)行政措施。
- 24. 图 8 显示截至 2014年 7 月 31 日,全部 25 个东欧缔约国均作过第七条第 5 款提交。

25. 图 9 显示了行动计划通过前后的第七条第 5 款提交走势。技秘处注意到 2002 年之前(行动计划启动之前),东欧已经有相当数量的缔约国(21 个,占总数 84%)作了首次第七条第 5 款提交,并有 15 个缔约国至少作过一次补充提交。 至报告截止日,提交数更高于 2002 年: 25 个缔约国 — 即东欧全部缔约国 — 都已作过首次和补充提交。在增长率方面,作补充提交的缔约国数增加了 40%,即从 2002 年 15 个缔约国(60%)增加到 2009 年的 25 个(100%)。而在首次提交方面,技秘处也确认提交率达到了 100%。但是,由于在 2002 年已有相当多的缔约国作了首次提交(25 个中的 21 个),增长率仅为 16%,即从 21 个(84%)增加到 25 个(100%)。技秘处谨此强调,按目前的报告标准,第七条第 5 款提交走势已稳定下来,该地区所有缔约国都已至少作过一次第七条第 5 款补充提交。重要的是应强调早在 2009 年,东欧所有缔约国均已作了首次第七条第 5 款持交起,至少)一次第七条第 5 款补充提交,故从统计的角度来看,从那时起到现在,图 9 列出的数据无任何变化(且今后也不会变)。

拉丁美洲及加勒比国家组(拉加组)缔约国(33个)



- 27. 应当注意的是在这 18 个缔约国中,有 5 个缔约国(即:玻利维亚多民族国、巴西、厄瓜多尔、格林纳达和乌拉圭)向技秘处提供了关于其各自履约措施的相关资料和(或)制定的立法文本,由此作出了第七条第 5 款补充提交。玻利维亚多民族国和巴西在本报告期以前已通过了覆盖所有初步措施的立法。格林纳达和乌拉圭在本报告期内通过了覆盖所有初步措施的立法。厄瓜多尔尚未通过覆盖所有初步措施的立法。
- 28. 因此,根据技秘处掌握的资料,至本报告截止日(2014年7月31日),已经制定覆盖初步措施的立法的拉加地区缔约国数目增加至13个(39%),已通过覆盖部分初步措施的立法的缔约国数目为11个(33%),尚未通过履约立法的缔约国数目减少至9个(27%)。换言之,有24个拉加地区缔约国(73%)已通过了全部或部分履行《公约》的立法和(或)行政措施。



- 30. 自行动计划通过以来,拉加组缔约国所作的第七条第 5 款提交不断增多。如图 12 所示,从 2003 年起首次提交和补充提交数量都一直在增加。经过几年连续 增长之后,从 2010 年到 2011 年间这一上升趋势趋于平缓,自此之后只略有上 升。
- 自行动计划通过以来,作了首次提交的缔约国数增加了 34%,即从 2002 年 15 31. 个(45%)增加到本报告截止目的 26 个(79%)。同样,补充提交的数量(细 线)也呈现类似的波动。至本报告截止日,增长率为 31%,即从 2002 年 10 个 缔约国(30%)增加到20个缔约国(61%)。不过,如图12所示,这一上升趋 势在 2007 年几乎停止下来 (例外之处是在 2012 年和 2014 年各有一项提交)。


- 32. 根据现有资料,至报告截止日,有 12 个缔约国(以不同方式,例如:电子邮件、信函、普通照会、口头)向技秘处通报了它们所采取的旨在通过/修订履约立法/规章的步骤(见图 13)。重要的是应注意到在这 12 个缔约国中,有 3 个缔约国(即:意大利、瑞士和美利坚合众国)在报告期起始时已经有了覆盖初步措施的立法,后又作了更新的第七条第 5 款提交(见表 3)。
- 33. 因此,根据技秘处掌握的资料,至本报告截止日(2014年7月31日),已经制定覆盖初步措施的立法的西欧及其他国家组缔约国数目为27个(93%),已通过覆盖部分初步措施的立法的缔约国数目为两个(7%)。换言之,有29个西欧及其他国家组缔约国(100%)已通过了全部或部分履行《公约》的立法和(或)行政措施。


34. 全部 29 个西欧及其他组缔约国均已作过至少一次第七条第 5 款提交(见图 14)。其中绝大部分(27 个缔约国,占 93%)在报告期起始时已通知技秘处它们通过了覆盖初步措施的立法,因此,现只剩两个缔约国(7%)尚未通过覆盖初步措施的立法。

35. 如图 15 所示,第七条第 5 款首次和补充提交走势的波动是一致的:2002 年前作首次提交的缔约国为 28 个 (97%),行动计划的启动带来了 3%的增长,这个数字 2003 年达到 29 个缔约国(100%)。在补充提交方面情况也差别不大:2002 年有 25 个缔约国(86%)至少作过一次第七条第 5 款补充提交,这个数字2003 年达到 27 个缔约国(93%),然后趋于平缓。换言之,除了这两类提交的增长率有区别(首次提交为 3%,补充提交为 7%)之外,令人瞩目的是,到2003 年西欧及其他国家组全部缔约国均已作过第七条第 5 款首次提交,且 29 个中的 27 个已至少作过一次补充提交。技秘处指出,按目前的报告标准,第七条第 5 款补充提交的走势已稳定下来,也就是说继续增长的可能性微乎其微。

- 36. 缔约国继续向技秘处提供关于本国立法和行政进程的资料。这既包括已有覆盖所有初步措施的履约立法和(或)行政措施并且已作第七条第 5 款提交的缔约国,以及已有覆盖部分初步措施的立法并且作过第七条第 5 款提交的缔约国,也包括尚未作任何第七条第 5 款提交的缔约国。
- 37. 至本报告截止日,在已落实了履约措施的 144 个缔约国(76%)中(见图 16),112 个(59%)已报称落实了覆盖所有初步措施的立法(见图 17),其余34个已采取了覆盖部分初步措施的履约措施(见图 18)<sup>8</sup>。
- 38. 在报告期内,在 112 个已经有覆盖所有初步措施的立法的缔约国中,7 个缔约国(即:阿尔巴尼亚、玻利维亚多民族国、保加利亚、意大利、斯洛文尼亚、瑞士和美利坚合众国)通知技秘处它们已通过进一步措施,以使本国履约立法的某些规定可以得到充分的执行。

图 16: 各区域已落实履约措施的缔约国数目





图 17: 各区域已有覆盖所有初步措施的立法的缔约国数目







图 18: 各区域已有覆盖部分初步措施的立法的缔约国数目



  - (a) 21 个缔约国(41%)已通过覆盖所有初步措施的立法(阿尔及利亚、布基纳法索、布隆迪、中非共和国、科摩罗、刚果、科特迪瓦、埃塞俄比亚、冈比亚、莱索托、利比里亚、马达加斯加、毛里塔尼亚、毛里求斯、摩洛哥、尼日尔、塞内加尔、南非、苏丹、突尼斯、赞比亚)。
  - (b) 8 个缔约国(16%)已通过覆盖部分初步措施的立法(博茨瓦纳、加蓬、马里、尼日利亚、卢旺达、塞舌尔、乌干达、津巴布韦)<sup>11</sup>。




图 21: 已落实履约措施的非洲缔约国数目




图 22: 非洲缔约国的立法进程现状








图 25: 已落实了履约措施的东欧缔约国数目




图 26: 东欧缔约国的立法进程现状




图 27: 已落实履约措施的拉加组缔约国数目






图 29: 已落实履约措施的西欧及其他组缔约国数目

71. 在报告期内,在 29 个西欧及其他组缔约国中,有一个缔约国向技秘处请求援助,以帮助其确定哪些领域的补充措施可有助于履约立法的有效执行,或者协助其起草这些领域的立法和(或)行政措施。

# 技秘处提供的法律援助

- 72. 大会在 C-14/DEC.12 号决定中鼓励技秘处根据请求继续以量身定制、系统化的方式提供技术援助,有效满足缔约国的需要,解决它们在国家履约方面遇到的问题和关切。在同一决定中,大会鼓励缔约国,尤其是希望获得落实第七条义务方面援助的缔约国,在它们认为合适时把所提供的援助利用起来(C-14/DEC.12,第4和第5段)。
- 73. 在 RC-3/3\*号文件中,第三届审议大会鼓励技秘处探讨提供量身定做的援助的 创新性方法,作为进一步推进第七条实施的潜在途径。另外,进一步请技秘处 在年度报告中列入一项包括对国家履约现状进行全面客观分析的评估,供决策 机构审议,从而跟踪履约进展并制定有针对性的援助方案。
- 74. 从履约措施的起草和发布一直到获得通过,技秘处可以在整个立法和行政工作 进程中提供援助,提高人们对《公约》所作规定的认识,指导人们如何能够在 不同的现实条件和法律条件下并在立法层面及越来越多地在行政层面上作出履 约的政策选择。

- 75. 报告期内, 技秘处向缔约国提供了关于 6 套履约立法和(或)行政措施草案的评点意见, 并举办和(或)参加了 10 项旨在促进各国从立法和(或)行政上履约的活动(见图 30)。这些活动可分为以下各类:
  - (a) 全球和区域性国家主管部门年会:
  - (b) 次区域法律讲习班;
  - (c) 现场双边技术援助访问(技援访问);及
  - (d) 为法律起草人和国家主管部门代表开办的实习方案。

- 76. 技秘处应请求审查履约措施草案并提出评点意见。缔约国请技秘处就立法提出评点意见时,它们尤其希望确保本国的草案符合《公约》的规定。请求提供评点意见的缔约国还希望深入了解的是,如果有其他缔约国所作的政策性选择类似于自己正在考虑的选择,这些选择对那些缔约国来说曾有何种利弊。在每一个常见履约步骤上都可以提供帮助(即政策性选择方面的指导、对履约立法草案的评点意见、制定规章方面的指导,以及对规章的评点意见)。
- 77. 图 31 显示了技秘处自 2004 年以来接到的提供意见的请求次数。应注意到直到 2010 年为此,这一数目是一直有变化的。不过自此之后,该数目从 2010 年的 40 次骤降到至本报告截止目的 7 次。




图 31: 各年度缔约国请求提供评点意见的趋势




图 32: 各年度非洲缔约国请求提供评点意见的趋势




图 34: 各年度东欧缔约国请求提供评点意见的趋势




图 35: 各年度拉加组缔约国请求提供评点意见的趋势




图 36: 各年度西欧及其他组缔约国请求提供评点意见的趋势

#### **Armenia** (29 April 1997)

- 1. 30 November 2013: During a bilateral meeting held during the course of the Fifteenth Annual Meeting of National Authorities, the representative of Armenia informed the Secretariat that Government Decision No. 861 of 8 July 2010 had been amended on 23 October 2013 to include key definitions of terms such as "chemical weapons", "toxic chemicals", and others. Formal notification is due to be forwarded to the Secretariat.
- 2. 24 December 2013: Under cover of a note verbale, the Permanent Representation of Armenia forwarded a note verbale from the National Authority to the Secretariat, notifying it of the introduction of the full definition of chemical weapons and the classification of chemical agents by Government Decision No. 1179 "On approval of the civil protection plan and reconstruction/rehabilitation actions in the case of an accident at chemical plants or in the case of chemical threat".
- 3. 3 July 2014: In response to the note verbale sent by the Secretariat on 28 February 2014, the Permanent Representation of Armenia, under cover of a note verbale, provided updates on the status of implementation of Article VII of the Convention by submitting the two matrixes duly filled in.
- 4. 6 8 May 2014: Armenia participated in the Thirteenth Regional Meeting of National Authorities of States Parties in Eastern Europe, held in Yerevan, Armenia, from 6 to 8 May 2014.

## Australia (29 April 1997)

Status: Legislation covers initial measures.

16 – 18 July 2014: Australia participated in the Twelfth Regional Meeting of National Authorities of States Parties in Asia held in New Delhi, India, from 16 to 18 July 2014.

## **Austria** (29 April 1997)

Status: Legislation covers initial measures.

26 June 2014: In response to the note verbale sent by the Secretariat on 28 February 2014, the Permanent Representative of Austria, under cover of a note verbale, provided updates from the National Authority on the status of implementation of Article VII of the Convention by submitting the two matrixes duly filled in.

#### Azerbaijan (30 March 2000)

Status: Legislation covers initial measures.

No update received by the Secretariat during the reporting period (1 August 2013 to 31 July 2014). Last update dated 19 to 21 May 2010.

## **Bahamas** (21 May 2009)

- 1. 30 November 2013: During a bilateral meeting held during the course of the Fifteenth Annual Meeting of National Authorities, the representative of the Bahamas informed the Secretariat that the draft legislation has been completed and stands before the office of legal affairs of the Ministry of Foreign Affairs and Immigration. The draft will be subsequently submitted to parliament.
- 2. 29 31 July 2014: The Bahamas participated in the Fifteenth Regional Meeting of National Authorities of States Parties in Latin America and the Caribbean, held in Santiago, Chile, from 29 to 31 July 2014.

#### **Bahrain** (29 April 1997)

Status: Article VII(5) submission; legislation does not cover initial measures. No draft. No update received by the Secretariat during the reporting period (1 August 2013 to 31 July 2014). Last update dated 6 June 2012.

## Bangladesh (29 April 1997)

Status: Article VII(5) submission; legislation covers initial measures. Draft regulations.

- 1. 30 November 2013: During a bilateral meeting held during the course of the Fifteenth Annual Meeting of National Authorities, the representative of Bangladesh informed the Secretariat that the import/export control law of 2010 contains many elements relevant to the Convention; Bangladesh undertakes to submit a copy of the text to the Secretariat.
- 2. 3 April 2014: In response to the note verbale sent by the Secretariat on 28 February 2014, the National Authority of Bangladesh, under cover of a note verbale, provided updates on the status of implementation of Article VII of the Convention by submitting the two matrixes duly filled in.
- 3. 16 18 July 2014: Bangladesh participated in the Twelfth Regional Meeting of National Authorities of States Parties in Asia held in New Delhi, India, from 16 to 18 July 2014.

#### Barbados (6 April 2007)

Status: No Article VII(5) submission. Draft law pending government approval. No update received by the Secretariat during the reporting period (1 August 2013 to 31 July 2014). Last update dated 25 June 2013.

## **Belarus** (29 April 1997)

Status: Legislation covers initial measures.

- 1. 24 June 2014: In response to the note verbale sent by the Secretariat on 28 February 2014, the Permanent Representation of Belarus, under cover of a note verbale, informed the Secretariat that there is no additional information concerning obligations under the Article VII of the Convention.
- 2. 6 8 May 2014: Belarus participated in the Thirteenth Regional Meeting of National Authorities of States Parties in Eastern Europe, held in Yerevan, Armenia, from 6 to 8 May 2014.

#### **Belgium** (29 April 1997)

Status: Article VII(5) submission; legislation covers initial measures. Draft regulations.

- 1. 22 November 2013: Under cover of a note verbale, the Permanent Representation of Belgium informed the Secretariat that the provisions concerning the confidentiality and verification regime listed in the matrix contained in the annual report on the "Status of implementation of Article VII of the chemical weapons convention as at 31 July 2013: Additional measures for States Parties that possess industrial facilities which are declarable under the Convention", are covered by the Belgian legislation.
- In response to the note verbale sent by the Secretariat on 2. 2 July 2014: 28 February 2014, the Permanent Representation of Belgium, under cover of a note verbale, provided updates on the status of implementation of Article VII of the Convention by submitting the two matrixes duly filled in. Furthermore, the Permanent Representation of Belgium informed the Secretariat that the regulations for the application of the Cooperation Agreement of 2 March 2007 between the Federal State, the Flemish region, the Wallonne region, and the Brussels-Capitale region were drafted by the competent authorities at both federal and regional level. Permanent Representation of Belgium emphasised that in adopting the various legal texts, the competent authorities incorporated the recommendations made by the Secretariat. Reference was made to the Royal Decree of 8 March 1993 (as amended by the Royal Decree of 2 April 2003) regulating the export and transit of weapons, ammunition, and materials intended specifically for the use of the military and the related technology; Schedule 1 chemicals and licensing regime for the import, export and transit.

## Belize (31 December 2003)

Status: No Article VII(5) submission (law orally reported as adopted).

29 – 31 July 2014: Belize participated in the Fifteenth Regional Meeting of National Authorities of States Parties in Latin America and the Caribbean held in Santiago, Chile, from 29 to 31 July 2014.

#### **Benin** (13 June 1998)

Status: No Article VII(5) submission. Draft law submitted to the legislative body.

4 – 6 June 2014: Benin participated in the Twelfth Regional Meeting of National Authorities of States Parties in Africa held in Nairobi, Kenya, from 4 to 6 June 2014.

## **Bhutan** (17 September 2005)

Status: Article VII(5) submission; legislation does not cover initial measures. Draft law pending government approval.

No update received by the Secretariat during the reporting period (1 August 2013 to 31 July 2014). Last update dated 22 July 2013

#### **Bolivia (Plurinational State of)** (13 September 1998)

Status: Article VII(5) submission; legislation covers the initial measures. Draft law submitted to legislative body.

- 1. 30 November 2013: During a bilateral meeting held during the course of the Fifteenth Annual Meeting of National Authorities, the representative of Bolivia (Plurinational State of) informed the Secretariat that a law on weapons control had been adopted on 18 September 2013. This law, which contains implementing measures relevant to the Convention, constitutes the legal basis for further regulations on which Bolivia (Plurinational State of) is already working.
- 2. 10 February 2014: Under cover of an e-mail, Bolivia (Plurinational State of) submitted the duly completed Implementation and Assessment Guide, in which the Secretariat was notified of the adoption of the "Ley de Armas de fuego, municiones, explosivos y otros materiales relacionados" on 28 August 2013; regulations are expected to enter into force 180 days after adoption of the law. This information qualifies as a submission under Article VII(5).

#### **Bosnia and Herzegovina** (29 April 1997)

Status: Legislation covers initial measures.

- 1. 5 August 2013: In response to the note verbale sent by the Secretariat on 28 March 2013, the Permanent Representation of Bosnia and Herzegovina, under cover of a note verbale, provided updates on the status of implementation of Article VII of the Convention by submitting the two matrixes duly filled in.
- 2. 6 8 May 2014: Bosnia and Herzegovina participated in the Thirteenth Regional Meeting of National Authorities of States Parties in Eastern Europe held in Yerevan, Armenia, from 6 to 8 May 2014.

#### **Botswana** (30 September 1998)

Status: Article VII(5) submission; legislation does not cover initial measures. Draft law pending government approval.

20 May 2014: Under the cover of an e-mail, the National Authority of Botswana informed the Secretariat that the Ministry of Defence, Justice and Security would be submitting the Bill on Prohibition of Chemical Weapons to parliament at its July 2014 session. The bill has already been published in the Official Gazette (Vol. LII. No. 26, dated 28 April 2014).

#### **Brazil** (29 April 1997)

Status: Legislation covers initial measures.

- 1. 23 July 2014: In response to the note verbale sent by the Secretariat on 28 March 2014, the Permanent Representation of Brazil, under cover of a note verbale, provided updates on the status of implementation of Article VII of the Convention by submitting the two matrixes duly filled in. Furthermore, details were provided on the legislative and administrative measures that implement each of the criteria contained in the matrixes included in the annual reports on the implementation of Article VII. This information qualifies as a submission under Article VII(5) of the Convention.
- 2. 29 31 July 2014: Brazil participated in the Fifteenth Regional Meeting of National Authorities of States Parties in Latin America and the Caribbean held in Santiago, Chile, from 29 to 31 July 2014.

#### **Brunei Darussalam** (29 August 1997)

Status: No Article VII(5) submission. Draft law pending government approval. No update received by the Secretariat during the reporting period (1 August 2013 to 31 July 2014). Last update dated 15 March 2010.

# Bulgaria (29 April 1997)

Status: Legislation covers initial measures.

- 1. 11 December 2013: In response to the third survey on the implementation of Decision C-14/DEC.4, Bulgaria declared that the decision has been fully implemented in 2013 and the existing decree No.16 of 4 May 2007 on terms and conditions for carrying out of activities with the toxic chemical substances and their precursors has been amended (SG, ed. 18 of 22 February 2013). The response to the questionnaire qualifies as a submission under Article VII(5).
- 2. 11 June 2014: In response to the note verbale sent by the Secretariat on 28 February 2014, Bulgaria, under cover of an e-mail, provided updates on the status of implementation of Article VII of the Convention by submitting the two matrixes duly filled in.
- 3. 6 8 May 2014: Bulgaria participated in the Thirteenth Regional Meeting of National Authorities of States Parties in Eastern Europe held in Yerevan, Armenia, from 6 to 8 May 2014.

# Burkina Faso (7 August 1997)

Status: Legislation covers initial measures.

4 - 6 June 2014: Burkina Faso participated in the Twelfth Regional Meeting of National Authorities of States Parties in Africa held in Nairobi, Kenya, from 4 to 6 June 2014.

## Burundi (4 October 1998)

Status: Article VII(5) submission; legislation covers initial measures. Draft decree on National Authority and considerations regarding substantive regulations.

1. 30 November 2013: During a bilateral meeting held during the course of the Fifteenth Annual Meeting of National Authorities, the representative of Burundi informed the Secretariat that the decree on the National Authority has not yet been signed owing to administrative challenges. Furthermore, the representative of Burundi informed the Secretariat that the drafting of the decree implementing the control regime will start after the decree on the National Authority is signed by the President.

2. 4 – 6 June 2014: During a bilateral meeting held during the course of the Twelfth Regional Meeting of National Authorities of States Parties in Africa, held in Kenya, the representative of the Burundi informed the Secretariat that the decree establishing the National Authority was amended by the Ministry of Foreign Affairs and sent back to the Office of the President. Furthermore, the Secretariat was informed that regulations are being drafted.

## Cambodia (18 August 2005)

Status: Article VII(5) submission; legislation covers the initial measures. No draft regulations.

16 – 18 July 2014: Cambodia participated in the Twelfth Regional Meeting of National Authorities of States Parties in Asia held in New Delhi, India, from 16 to 18 July 2014.

#### Cameroon (29 April 1997)

Status: Article VII(5) submission. Draft law pending government approval.

- 1. 30 November 2013: During a bilateral meeting held during the course of the Fifteenth Annual Meeting of National Authorities, the representative of Cameroon informed the Secretariat that two drafts are pending governmental approval: (1) draft law for the implementation of the Convention; (2) a draft decree on the National Authority. No date has yet been set for the submission of the draft law to the National Assembly. However, the representative of Cameroon envisaged that both drafts should be enacted by mid-2014.
- 2. 4 6 June 2014: Cameroon participated in the Twelfth Regional Meeting of National Authorities of States Parties in Africa held in Nairobi, Kenya, from 4 to 6 June 2014.

# **Canada** (29 April 1997)

Status: Legislation covers initial measures.

No update received by the Secretariat during the reporting period (1 August 2013 to 31 July 2014). Last update dated 14 April 2010.

#### Cabo Verde (9 November 2003)

Status: Article VII(5) submission. Draft law pending government approval.

- 1. 29 October 2013: Under cover of an e-mail, Cabo Verde informed the Secretariat that draft national implementing legislation was translated into Portuguese and sent to the Ministry of Justice and Ministry of Foreign Affairs in July 2013. Subsequently, the Ministry of Justice submitted it to the Council of Ministers.
- 2. 22 April 2014: Under cover of an e-mail dated 22 April 2014, the National Authority informed the Secretariat that the national legislation of Cabo Verde has been submitted to the parliament and is expected to be adopted shortly.
- 3. 10 July 2014: Under cover of an e-mail, the National Authority of Cabo Verde informed the Secretariat that the legislation has been adopted by the parliament and has been sent to the President of the Republic for promulgation.

## Central African Republic (20 October 2006)

Status: Legislation covers initial measures.

- 1. 30 November 2013: During a bilateral meeting held during the course of the Fifteenth Annual Meeting of National Authorities, the representative of Central African Republic informed the Secretariat that the adoption of an implementing decree that would cover the establishment of the National Authority, declarations, and inspections was being contemplated. However, because of internal challenges, the drafting of that text has not yet started.

- 5. 11 February 2014: Under cover of a note verbale, the Permanent Representation of Yemen submitted to the Secretariat a copy of Law No. 15/2014 on the prohibition of the production, storage, development and use of chemical weapons. This qualifies as Yemen's first submission under Article VII(5). The legislation of Yemen covers all initial measures.
- 6. 8 April 2014: Under cover of a note verbale, the Permanent Representation of Yemen requested to be provided copy of administrative texts adopted by other States Parties that could be used as model. Copies of the requested documents were subsequently provided.
