# CALL FOR NOMINATIONS FOR THE FIRST ANNUAL MEETING OF NATIONAL AUTHORITIES OF STATES PARTIES IN THE WESTERN EUROPEAN AND OTHERS GROUP ONLINE 2 JULY 2024

- 1. The Technical Secretariat of the OPCW (the Secretariat) wishes to invite representatives of National Authorities to attend the first technical meeting on the implementation of the Chemical Weapons Convention (the Convention) for National Authorities of States Parties of the Western European and Others Group (WEOG), which will be held virtually on 2 July 2024, from 10:00 to 13:00 (CET).
- 2. This online meeting of National Authorities will serve as a forum for States Parties in the WEOG region to discuss technical implementation issues, challenges, best practices, and other issues relating to the Convention.
- 3. The purpose of the meeting is to facilitate an exchange of information and views on:
  - (a) activities in the Verification, Inspectorate, and International Cooperation and Assistance Divisions:
  - (b) experiences and challenges related to resolving transfer discrepancies; and
  - (c) best practices regarding outreach and engagement with the chemical industry.
- 4. The expected results of the meeting are to:
  - (a) provide participants with relevant and updated information on activities by the Secretariat relevant to States Parties in WEOG;
  - (b) deepen the understanding of challenges and best practices in relation to specific verification issues; and
  - (c) strengthen the network among Convention focal points and National Authorities of States Parties in WEOG.
- 5. The provisional programme for this meeting is included as the Annex to this Note.
