#### NOTE BY THE DIRECTOR-GENERAL

#### TRANSFERS OF FUNDS DURING 2023

- 1. Regulation 4.5 of the OPCW Financial Regulations and Rules states that the Director-General shall notify the Executive Council (the Council) of any transfers of appropriated funds between programmes within a budget chapter. In pursuance of this Financial Regulation, the Director-General in this Note informs the Council that, during the period from 1 January to 31 December 2023, none of the transfers made between programmes exceeded 10% of the original appropriation for the programme to which the transfers were made. A summary of such transfers is presented in Annex 1 to this Note.
- 2. Financial Regulation 4.6 states that the Director-General shall notify the Council of any transfers of appropriated funds between subprogrammes within a budget programme. None of the transfers made between subprogrammes exceeded 15% of the original appropriation for the subprogramme to which the transfers were made. A summary of such transfers is presented in Annex 2 to this Note.
- 3. Recalling that the Programme and Budget for 2022–2023 (C-26/DEC.11, dated 1 December 2021) was approved at the subprogramme level, the transfers listed in both annexes to this Note were processed primarily to cover budget shortfalls. The transfers in 2023 were made without detriment to approved programme activities. The transfers were necessary in order to address the impacts of the historic, unforeseeable spike in global inflation that occurred in 2023. In such an unstable inflationary environment, rapidly rising prices inevitably reduced the purchasing power of the Organisation. The higher-than-forecast costs put strong pressure on the OPCW's budget in crucial cost areas, such as utilities, rents, travel, and staff remuneration, as a result of obligatory increases mandated by the International Civil Service Commission. Extraordinary mitigation measures were necessary in 2023 in order to avoid a budget overspend, including higher levels of funding withheld as contingency on non-staff costs and the temporary retention of savings on vacant staff positions. While the Secretariat successfully mitigated the inflationary impacts in 2023, the mitigation measures undertaken would not be sustainable year on year. The 2024-2025 Biennium Programme and Budget (C-28/DEC.9, dated 29 November 2023) was formulated in recognition of this fact, with a view to keeping costs to the minimum necessary while addressing the historic inflationary pressures.

4. The Technical Secretariat will report in detail on the overall utilisation and impacts of OPCW budgetary resources as part of the 2023 programme performance review. A programme performance report for 2023 will be submitted to the Council at its 106th Session.
