The Council **noted** the opening statement by the Director-General (EC-106/DG.21, dated 9 July 2024).

4. AGENDA ITEM FOUR – Reports by the Vice-Chairpersons on the activities conducted under their respective clusters of issues

- 4.1 The Vice-Chairpersons and coordinators for clusters of issues reported to the Council on informal consultations held during the intersessional period: Ambassador Mutlaq bin Majed Al Qahtani of Qatar on chemical weapons issues; Ambassador Salima Abdelhak of Algeria on chemical industry and other Article VI issues; Ambassador Beti Jacheva of North Macedonia on administrative and financial issues; and Ambassador Giorgio Novello of Italy on legal, organisational, and other issues.
- 4.2 The Chairperson briefed the Council on his own activities during the intersessional period.
- 4.3 Mr Jerzy Gierasimiuk of Poland, the co-facilitator on the Programme and Budget of the OPCW, reported on the consultations during the intersessional period carried out with his co-facilitator, Mr Jorge Francisco de la Lama Rebollo of Mexico.
- 4.4 The Council **expressed appreciation** for the work done by the outgoing facilitators, Mr Frank Groome of Ireland, for his work as co-facilitator for the Programme and Budget of the OPCW, Ms Rebecca Kimbrell of the United States of America for her work as facilitator for the reports of the Office of Internal Oversight and the External Auditor, and Ms Fatima Hamdia Tanweer of Pakistan for her work as facilitator on the full implementation of Article XI. The Council **welcomed** the appointment during the intersessional period of Mr Jorge Francisco de la Lama Rebollo of Mexico as the new co-facilitator for the Programme and Budget of the OPCW.

- 6. AGENDA ITEM SIX Status of implementation of the Chemical Weapons Convention
 - **Subitem 6(a):** Reports by the Director-General on destruction related issues
- Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6, dated 15 February 2012), the Council **considered** and **noted** a report by the Director-General on the overall progress with respect to the destruction of abandoned chemical weapons (EC-106/DG.16, dated 1 July 2024).
 - Subitem 6(b): Implementation of the Conference of the States Parties and Executive Council decisions on destruction-related issues
- 6.2 The Technical Secretariat (the Secretariat) provided an update to the Council on its destruction-related verification activities and on Article III-related submissions made during the intersessional period (the presentations were posted on the external server of the OPCW).
- 6.3 The delegation of Japan briefed the Council on its destruction-related activities (the presentation was posted on the external server of the OPCW). The delegation of China also briefed the Council on its destruction-related activities (the presentation was posted on the external server of the OPCW), and made a further statement.
- 6.4 The following delegations made statements: Japan and the Syrian Arab Republic (observer).
- 6.5 The following delegations exercised their right of reply: China and Japan.
- 6.6 Further to a decision by the Council at its Sixty-Seventh Session (EC-67/DEC.6) and the destruction plan beyond the year 2022 for the chemical weapons abandoned by Japan in China (EC-101/DEC.2, dated 4 October 2022), attached as annex 3 to Council decision EC-67/DEC.6, a national paper by China (EC-106/NAT.3, dated 7 June 2024) and a national paper by Japan (EC-106/NAT.2, dated 10 June 2024) on the overall progress of the destruction of chemical weapons abandoned by Japan on the territory of China were circulated to the members of the Council.

- 6.7 The Council **reaffirmed** the obligation to complete the destruction of all abandoned chemical weapons (ACW) in accordance with the provisions of the Convention and the relevant decisions of the Council by recalling that the Abandoning State Party shall provide all necessary financial, technical, expert, facility as well as other resources and that the Territorial State Party shall provide appropriate cooperation, and **expressed its determination** to remain seized of the matter, and **urged** the Abandoning State Party to continue to make the fullest possible effort to complete the destruction of chemical weapons abandoned by Japan on the territory of China as early as possible in accordance with the Council's decision (EC-67/DEC.6) and its annex 3 in a faithful manner, and to address challenges including ensuring the safety of people and protecting the environment.
- 6.8 The Council **recalled** that the Destruction Plan Beyond the Year 2022 for the Chemical Weapons Abandoned by Japan in the People's Republic of China (EC-101/DEC.2) stipulated the common recognition regarding the destruction of ACW with the Mobile Destruction Facility, the destruction of ACW in Haerbaling (Jilin Province), the destruction of other ACW, including consultation in making a medium- to long-term plan for the excavation of ACW, and the consolidation of ACW storehouses, continuing to use its best efforts to collect and provide information on traces of ACW by the Abandoning State Party and continuing to hold consultations, and that the relevant States Parties jointly affirmed that they would accelerate in all aspects the destruction process and that their best efforts will be used towards the completion of the destruction of ACW as early as possible.
- The Council **recalled** that the review of the destruction of ACW was welcomed by the Third Review Conference and the report of the Third Review Conference (RC-3/3*, dated 19 April 2013), which reaffirmed the role of the Council, the Conference of the States Parties (the Conference), and the Review Conference with regard to the issues related to ACW destruction as defined in the provisions of the Convention and in the Council's decision (EC-67/DEC.6), and **welcomed** the review of this issue by the Fourth Review Conference and **noted** the constructive discussion related to this issue at the Fifth Review Conference.
- 6.10 The Council **welcomed** that a total of seven on-site inspections to the ACW facilities had been successfully conducted in 2024. The Council **welcomed** the joint invitation by China and Japan to the Chairperson of the Council, the Director-General, and a delegation representing the Council to visit the ACW sites in Mudanjiang and Haerbaling in September 2024.

Subitem 6(c): Elimination of the Syrian chemical weapons programme

- 6.11 Further to its decision at its Eighty-Third Session (EC-83/DEC.5, dated 11 November 2016), the Council decided to place "Elimination of the Syrian Chemical Weapons Programme" on the agenda of all future Council sessions until the Council determines that all elements of the Syrian chemical weapons programme have been eliminated.
- 6.12 As stated in Note by the Director-General EC-81/DG.5 (dated 25 January 2016), all of the chemicals declared by the Syrian Arab Republic that had been removed from its territory in 2014 have been destroyed. The Secretariat has also verified the destruction of all 27 chemical weapons production facilities declared by the Syrian Arab Republic (EC-89/DG.1, dated 24 July 2018).

- 6.13 The Secretariat provided a briefing to States Parties on 2 July 2024 on its activities related to the Syrian Arab Republic, including on the activities of the Declaration Assessment Team, the OPCW Fact-Finding Mission in Syria, and the Investigation and Identification Team.
- 6.14 The Council **noted** four reports by the Director-General reporting on progress in the elimination of the Syrian chemical weapons programme (EC-106/DG.2, dated 25 March 2024; EC-106/DG.5, dated 24 April 2024; EC-106/DG.7, dated 24 May 2024; and EC-106/DG.14, dated 24 June 2024).
- 6.15 The Council **noted** four national papers by the Syrian Arab Republic on the activities related to the destruction of Syrian chemical weapons and their production facilities (EC-106/P/NAT.1, dated 15 March 2024; EC-106/P/NAT.2, dated 15 April 2024; EC-106/P/NAT.3, dated 15 May 2024; and EC-106/P/NAT.4, dated 14 June 2024).
- 6.16 The following delegations made statements: Hungary (observer) (on behalf of the European Union and Albania, Andorra, Bosnia and Herzegovina, Georgia, Iceland, Liechtenstein, Monaco, Montenegro, North Macedonia, Norway, the Republic of Moldova, San Marino, and Ukraine), the United States of America, France, China, Denmark (on behalf of Denmark, Finland, Iceland, Norway, and Sweden), Italy, the Islamic Republic of Iran, Japan, Belgium, Saudi Arabia, the Syrian Arab Republic (observer), the Russian Federation (observer), the Bolivarian Republic of Venezuela (observer), Austria (observer), and Cuba (observer).
- 6.17 The following delegations exercised their right of reply: the United States of America and the Syrian Arab Republic (observer).
- 6.18 The Council **noted** a Note by the Director-General entitled "Report on the Work of the Declaration Assessment Team" (EC-106/HP/DG.1, dated 4 July 2024).
- 6.19 The Secretariat circulated a Note by the Secretariat entitled "Report of the OPCW Fact-Finding Mission in Syria regarding Incidents of Alleged Use of Toxic Chemicals as a Weapon in Qalib Al-Thawr, Al-Salamiyah, on 9 August 2017, and Al-Balil, Souran, on 8 November 2017, in Hama Governorate, the Syrian Arab Republic" (S/2295/2024, dated 11 June 2024).

- 13.2 Germany submitted a working paper entitled "Follow-up to the Fifth Special Session of the Conference of the States Parties to Review the Operation of the Chemical Weapons Convention Engagement with Civil Society" at the 103rd Session of the Council (EC-103/WP.2, dated 4 July 2023).
- 13.3 The delegations of Germany and Costa Rica updated the Council on the ongoing consultations on engagement with civil society.
- 13.4 The following delegations made statements: China, the Islamic Republic of Iran, New Zealand (on behalf of Australia, Canada, and New Zealand), the Russian Federation (observer), the Syrian Arab Republic (observer), the Bolivarian Republic of Venezuela (observer), and Sweden (observer).
- 13.5 The Council **took note** of the continuing consultations regarding the engagement with civil society.

Other issues

- 13.6 The delegations of Mexico and Ghana made a joint statement on behalf of Albania, Andorra, Australia, Austria, Belgium, Bosnia and Herzegovina, Botswana, Bulgaria, Canada, Chile, Colombia, Costa Rica, Croatia, Cyprus, the Czech Republic, Denmark, the Dominican Republic, Ecuador, Estonia, Finland, France, Georgia, Germany, Ghana, Greece, Iceland, Ireland, Italy, Japan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Mexico, Monaco, Montenegro, the Netherlands, New Zealand, North Macedonia, Norway, Panama, Peru, Poland, Portugal, the Republic of Korea, the Republic of Moldova, Romania, San Marino, Serbia, Slovenia, Spain, Sweden, Switzerland, Thailand, Türkiye, Uganda, the United Kingdom of Great Britain and Northern Ireland, and the United States of America.
- 13.7 The delegation of Chile also made a statement.

14. AGENDA ITEM FOURTEEN – Credentials of representatives of the members of the Executive Council

The Council **considered** and **approved** a report by the Director-General on the credentials of representatives of members of the Council, which covers the credentials of the newly elected members of the Council (EC-106/DG.20, dated 10 July 2024).

15. AGENDA ITEM FIFTEEN – Provisional agenda for the Twenty-Ninth Session of the Conference of the States Parties

The Council **drew up** the provisional agenda for the Twenty-Ninth Session of the Conference (EC-106/DG.12, dated 19 June 2024).

16. AGENDA ITEM SIXTEEN – Draft report of the Executive Council on the performance of its activities

The Council **considered** and **approved** a report on the performance of its activities in the period from 15 July 2023 to 11 May 2024 (EC-106/3 C-29/2, dated 9 July 2024), and **submitted** it to the Conference for consideration at its Twenty-Ninth Session.

17. AGENDA ITEM SEVENTEEN – Dates for the regular sessions of the Executive Council in 2025

The Council **decided** that the 108th Session of the Council shall be held from 4 to 7 March 2025, that the 109th Session of the Council shall be held from 8 to 11 July 2025, and that the 110th Session of the Council shall be held from 7 to 10 October 2025.

- 18.4 The Council **decided** to include an agenda item on emerging technologies on the agenda of all future regular sessions of the Council.

18.5 The delegations of Brazil and Australia (observer) (on behalf of Australia, Canada, and New Zealand) made statements on other issues under this agenda item.
