**NOTE BY THE DIRECTOR-GENERAL****STATUS REPORT ON THE TIMELY SUBMISSION BY STATES PARTIES OF  
DECLARATIONS UNDER ARTICLE VI OF THE CHEMICAL WEAPONS  
CONVENTION FOR THE PERIOD 1 JANUARY TO 31 DECEMBER 2024****1. INTRODUCTION**

- 1.1 This Note, which is being submitted to the Executive Council (the Council) for consideration at its 108th Session, provides an update on the information and analysis related to the implementation by the Technical Secretariat (the Secretariat) and States Parties of the decision “Timely Submission by States Parties of Declarations under Article VI of the Convention” (EC-51/DEC.1, dated 27 November 2007). It covers the period 1 January to 31 December 2024.
- 1.2 In response to Council decision EC-51/DEC.1, which requests all States Parties to the Chemical Weapons Convention (the Convention) to meet their obligations regarding annual declarations in a timely manner, the Secretariat sent a note verbale to all States Parties (NV/VER/DEB-67/24, dated 23 January 2024), reminding them of the requirements of the decision and of the deadline for submission of the annual declaration on past activities (ADPA) for 2023.
- 1.3 In the decision, the Council also requests the Secretariat “to make its requirements known at regional meetings and at any other venues that the Secretariat deems effective”. During the reporting period, the decision was highlighted at a number of events, including: four regional meetings of National Authorities (in Africa, Asia, Eastern Europe, and Latin America and the Caribbean); one training course for representatives of National Authorities on fulfilling Article VI obligations under the Convention (global); one regional training course for National Authority representatives involved in fulfilling Article VI requirements (Latin America and the Caribbean); one technical meeting on Convention implementation (Western Europe and Others Group); one workshop on advancing Convention implementation for Portuguese-speaking countries; and the Twenty-Sixth Annual Meeting of National Authorities. Furthermore, the Secretariat has emphasised the importance of the timely submission of declarations during several bilateral meetings with Permanent Representatives and National Authorities.



## **2. SUBMISSION OF INITIAL DECLARATIONS UNDER ARTICLE VI**

During the reporting period, the Secretariat did not receive any initial declarations. As at 31 December 2024, only one State Party, Tonga, had yet to submit its initial declaration under Article VI. The Secretariat will continue to work with this State Party towards the submission of its outstanding initial declaration.

## **3. SUBMISSION OF ANNUAL DECLARATIONS UNDER ARTICLE VI**

- 3.1 The deadline for the submission of ADPA 2023 was 30 March 2024. As at that date, the Secretariat had received ADPA 2023 from 76 States Parties, including eight States Parties that notified the Secretariat that they had no declarable facilities or activities (“nil declarations”).<sup>1</sup> An additional 20 States Parties submitted information on declarable facilities or activities for ADPA 2023 after 30 March 2024, and six more States Parties notified the Secretariat that they had no declarable facilities or activities as specified in the Verification Annex to the Convention.
- 3.2 As at 31 December 2024, a total of 88 States Parties had submitted declarations for declarable facilities or activities for 2023. Of these, 68 States Parties (77%) were on time in submitting their declarations. The current status of submission of ADPA 2023 is detailed in Annexes 1 and 2 to this report.
- 3.3 The deadlines for the submission of the annual declaration on anticipated activities (ADAA) for 2025 were 2 October 2024 (for Schedule 1 facilities) and 1 November 2024 (for Schedule 2 and 3 plant sites).
- 3.4 As at the deadline of 2 October 2024, 21 States Parties, with previously declared Schedule 1 chemicals and related facilities, submitted ADAA 2025 on time (91%). Two States Parties submitted their ADAAs after the deadline. In addition, one State Party notified the Secretariat, within the deadline, that it anticipated having no declarable Schedule 1 facilities in 2025.
- 3.5 As at the deadline of 1 November 2024, 37 out of 39 States Parties with declarable plant sites had submitted their ADAA 2025 for Schedule 2 and 3 chemicals. Two States Parties submitted their ADAAs after the deadline. Accordingly, 95% of these declarations were on time. In addition, four States Parties notified the Secretariat that they anticipated having no declarable activities with regard to Schedule 2 or 3 facilities in 2025 (all four States Parties’ declarations were within the deadline).
- 3.6 A total of 41 States Parties declared activities and facilities for 2025 in relation to Schedule 1 and/or Schedule 2 and Schedule 3 chemicals, and three more States Parties notified the Secretariat that they anticipated having no declarable activities. Of the States Parties with declarable activities, and in regard to their ADAA 2025, 39 (95%) were on time in submitting at least part of their declaration. The status of submission of ADAA 2025 is detailed in Annexes 3 and 4 to this report.

<sup>1</sup> Although the submission of nil declarations is not a requirement of the Convention, a number of States Parties choose to provide the Secretariat with such information voluntarily.

3.7 In paragraph 4 of EC-51/DEC.1, the Council requests “States Parties that anticipate difficulties in regard to the timely submission of their declarations in accordance with the deadlines in the Convention to inform the Secretariat at the earliest possible date of the circumstances of such difficulties”. As at the deadline for the submission of ADPA 2023, one State Party (Ireland) had submitted such information.

#### **4. ONGOING EFFORTS TO ASSIST STATES PARTIES**

4.1 The Secretariat stands ready to hold bilateral meetings with representatives of States Parties with regard to their ADPAs and ADAAs, to offer advice and assistance where needed. Furthermore, the Secretariat provides customised support to those States Parties that encounter difficulties in identifying declarable activities, collecting data for declaration, and preparing and submitting their annual declarations, through bilateral consultations with National Authorities and training of National Authorities’ personnel. The Secretariat will continue to work with the States Parties concerned towards the timely submission of complete and accurate annual declarations.

4.2 The Secretariat continues to support States Parties in using the Secure Information Exchange System (SIX) for the exchange of confidential information, including declarations. Currently, 126 users from 66 States Parties are registered to use SIX. In 2024, the system was used by 41 States Parties for the submission of ADPA 2023. Further details and updates regarding the system are available in the Note by the Secretariat S/2291/2024 (dated 27 May 2024). #### **5. ANALYSIS OF TRENDS IN THE TIMELINESS OF PAST ADPA SUBMISSIONS<sup>2,3</sup>**

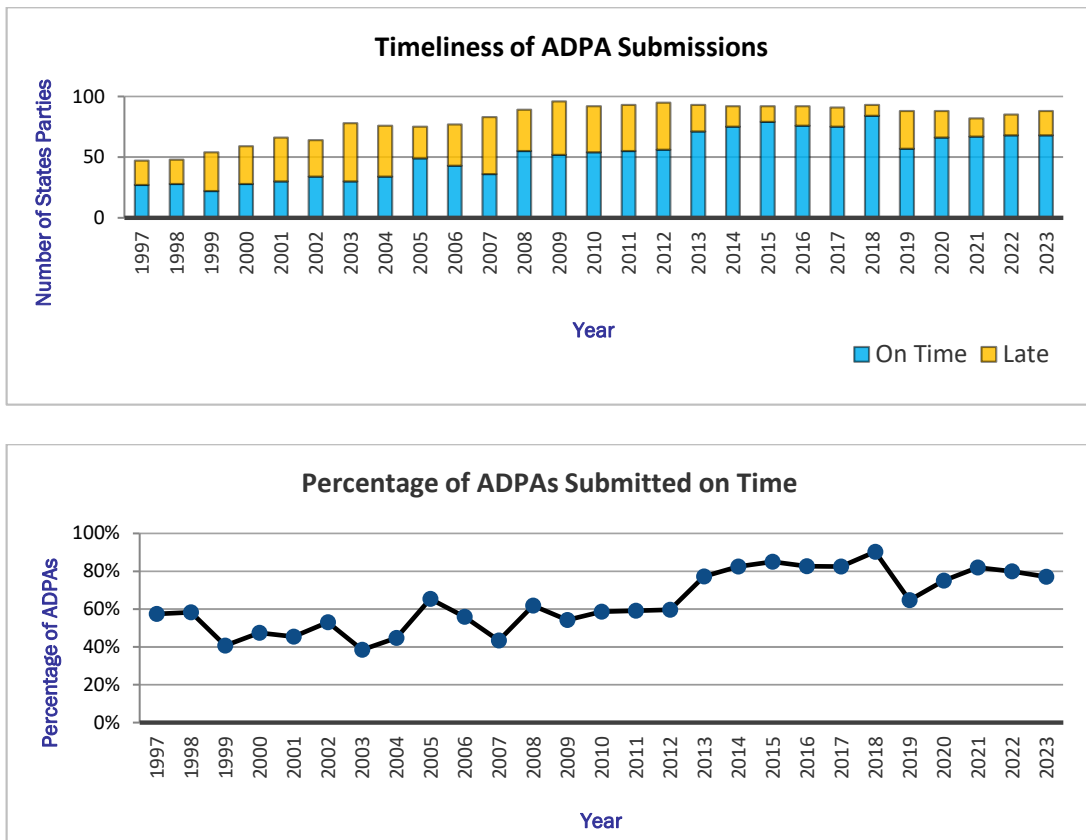

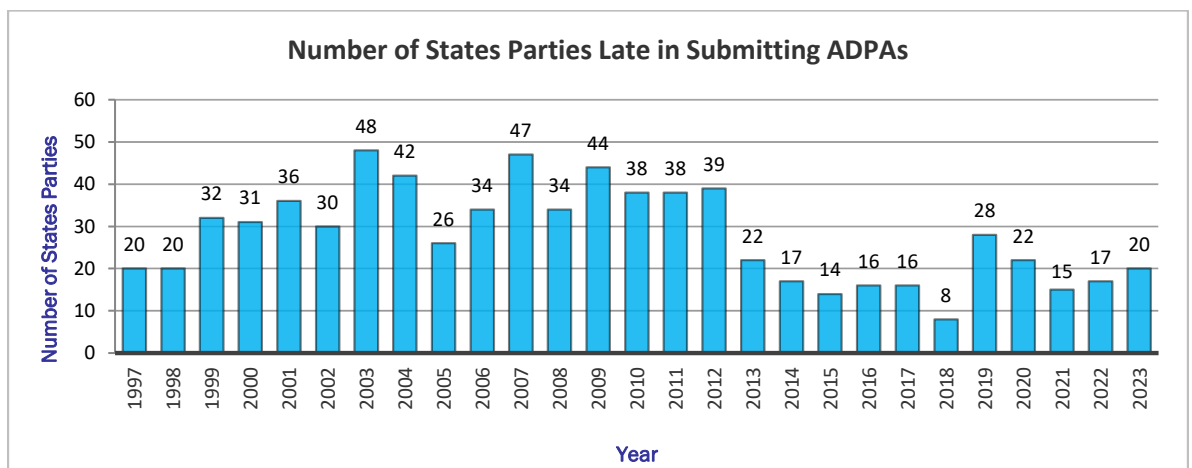
**FIGURE 1: OVERVIEW OF SUBMISSIONS OF ADPA 1997 – 2023**

5.1 The overall number of States Parties with declarable activities reported in ADPA 2023 (as at 31 December 2024) is higher than in ADPA 2022 (as at 31 December 2023), namely, 88 compared to 85. More statistics on ADPA submissions from 1997 to 2023 are shown in Figure 1 below.

5.2 In order to highlight the importance of timely submissions, and for verification purposes, the Secretariat contacted eight States Parties that had declarable activities in 2022 and did not submit their ADPA 2023, seeking clarification as to whether those activities remained declarable in 2023.

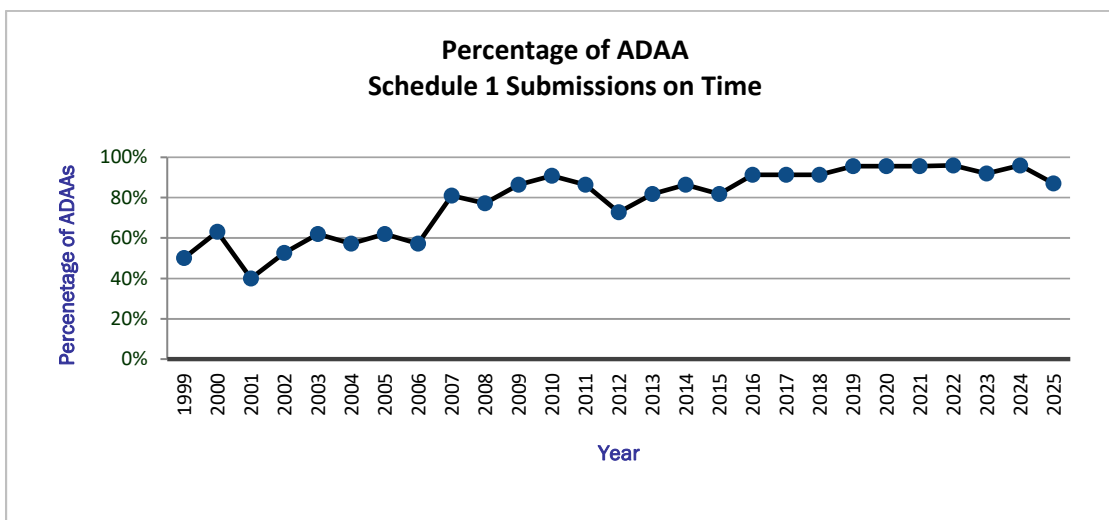
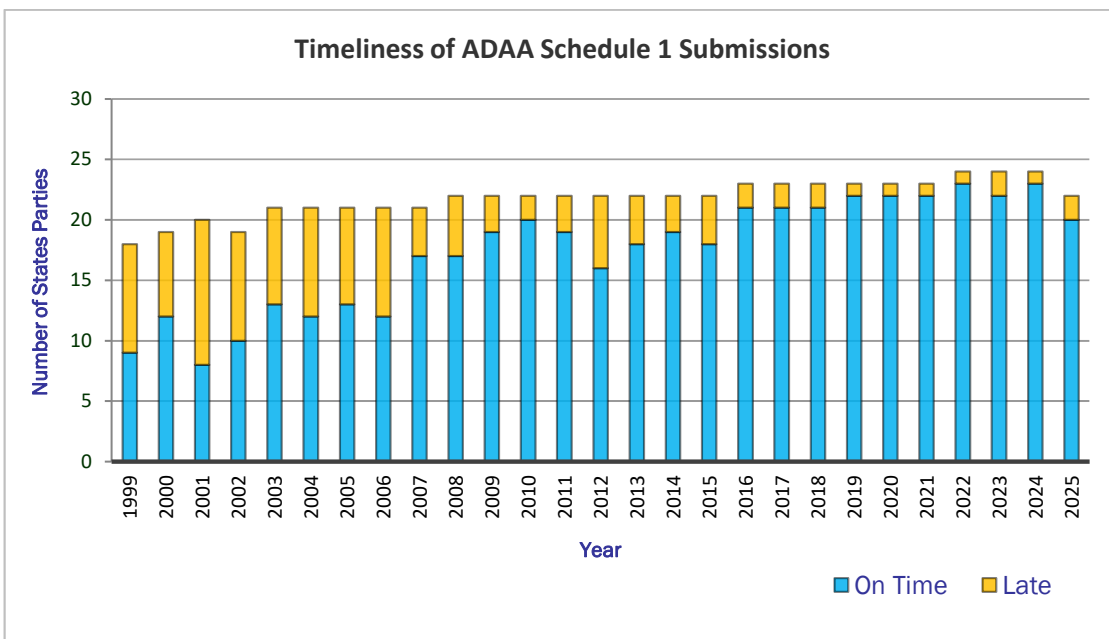
5.3 As at 31 December 2024, 20 States Parties were late in submitting declarable activities for ADPA 2023. Ten of these States Parties submitted their declarations within 30 days of the deadline and 10 submitted their declarations more than 30 days after the deadline. An overview of late submissions of ADPA from 1997 to 2023 is provided in Figure 2.

**FIGURE 2: OVERVIEW OF LATE SUBMISSIONS OF ADPA 1997 – 2023**

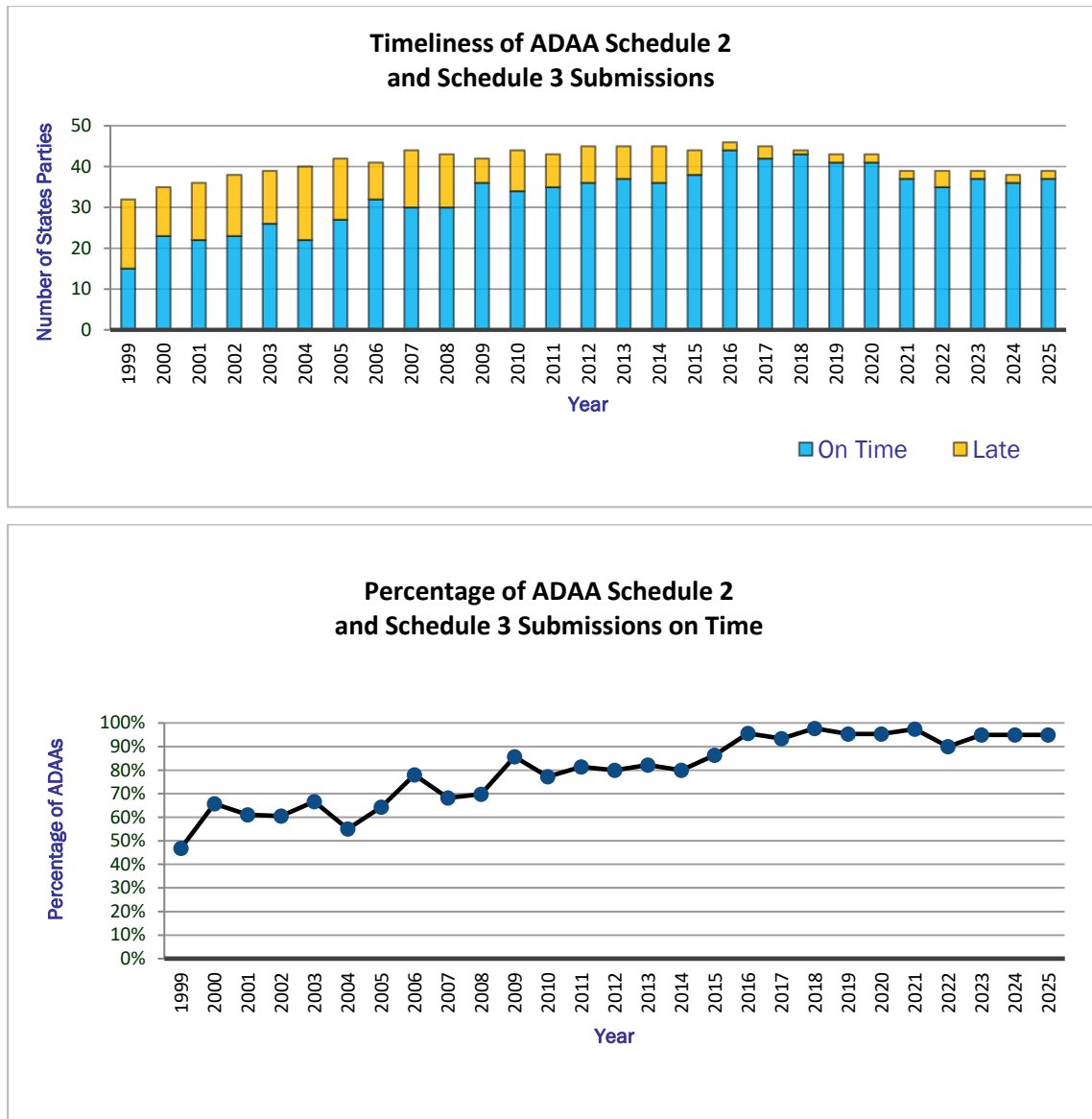


- 5.4 For ADAA 2025 for Schedule 1 facilities, 21 States Parties submitted their declarations on time, compared to 23 States Parties for ADAA 2024.
- 5.5 Regarding ADAA 2025 for Schedule 2 and 3 plant site declarations, 37 States Parties submitted their declarations on time, compared to 36 States Parties for ADAA 2024. Two States Parties submitted their ADAA 2025 after the deadline.
- 5.6 More statistics on ADAA submissions from 1999 to 2025 are shown below in Figure 3 (for Schedule 1 facilities) and in Figure 4 (for Schedule 2 and Schedule 3 plant sites).
