NOTE BY THE DIRECTOR-GENERAL

STATUS REPORT ON THE TIMELY SUBMISSION BY STATES PARTIES OF DECLARATIONS UNDER ARTICLE VI OF THE CHEMICAL WEAPONS CONVENTION FOR THE PERIOD FROM 1 JANUARY TO 31 MAY 2012

1. Introduction

- 1.1 This Note, which is being submitted to the Executive Council for its consideration at its Sixty-Ninth Session, provides an update to the information and analysis related to the implementation by the Technical Secretariat (hereinafter "the Secretariat") and States Parties of the decision "Timely Submission by States Parties of Declarations under Article VI of the Convention" (EC-51/DEC.1, dated 27 November 2007); it covers the period from 1 January to 31 May 2012.¹
- 1.2 In response to the above-mentioned decision, which requires "all States Parties to meet their obligations regarding annual declarations in a timely manner", the Secretariat sent further notes verbales to all Member States (NV/VER/DEB/172608/12, dated 31 January 2012), reminding them of the requirements of the decision and of the deadline for submission of annual declarations on past activities (ADPAs) for the year 2011.
- 1.3 The decision also requests the Secretariat "to make its requirements known at regional meetings and at any other venues that the Secretariat deems effective". During the reporting period, the decision was highlighted during three events: two regional meetings of National Authorities (in Africa and in Eastern Europe) and a basic training course for representatives of National Authorities in The Hague.

2. Submission of initial declarations under Article VI

- 2.1 The current status in relation to the situation of submission of outstanding initial declarations is detailed in Annex 1.
- 2.2 During the reporting period, the Secretariat did not receive any additional initial declarations. Hence, as at 31 May 2012, the situation is unchanged from the end of 2011 with the following 10 States Parties yet to submit their initial declarations under

- Article VI: Cape Verde, the Congo, Guinea-Bissau, Haiti, Kiribati, the Solomon Islands, Timor-Leste, Tonga, Tuvalu, and Vanuatu.
- 2.3 During the reporting period, the Secretariat held bilateral meetings on declaration issues with three of these States Parties: Cape Verde, the Congo, and Guinea-Bissau.

3. Submission of annual declarations under Article VI

- 3.1 The current status of submissions of ADPAs for 2011 is detailed in Annexes 2 and 3 of this report. The current status of submissions of annual declarations on anticipated activities (ADAAs) for 2012 is detailed in Annexes 4 and 5.
- 3.2 The deadline for the submission of ADPAs for 2011 was 30 March 2012. As at 30 March 2012, the Secretariat had received ADPAs for 2011 from 59 States Parties, including four States Parties that notified the Secretariat that they had no declarable facilities or activities (nil declarations²). An additional 19 States Parties submitted ADPAs for declarable facilities or activities for 2011 after 30 March 2012, and four more States Parties notified the Secretariat that they had no declarable facilities or activities under at least one Part, or paragraph, of the Verification Annex to the Convention (hereinafter "the Verification Annex"). One State Party that had submitted a partial declaration by the deadline also submitted declarations under additional Parts, or paragraphs, of the Verification Annex. Of the 74 States Parties that submitted a declaration for declarable facilities or activities for ADPA 2011, 55 (74%) were on time in submitting at least part of their declaration.
- 3.3 The deadlines for the submission of ADAAs for 2012 were 2 October 2011 (for Schedule 1 facilities) and 1 November 2011 (for Schedule 2 and 3 plant sites). During the reporting period, two additional States Parties submitted their ADAAs for 2012 on declarable facilities and activities. Furthermore, four additional States Parties notified the Secretariat that they had no declarable facilities or activities in regard to ADAA 2012. A total of 47 States Parties declared activities and facilities for 2012, and a further 10 States Parties notified the Secretariat that they had no declarable activities. Of the States Parties with declarable facilities or activities in regard to their ADAAs for 2012, 36 (77%) were on time in submitting at least part of their declaration.
- 3.4 Subparagraph 2(b) of EC-51/DEC.1 states that "each State Party that has indicated in its initial declaration that it does not have any declarable activities under Article VI of the Convention, but which now finds that it has declarable activities taking place within its territory, [is requested] to submit the relevant annual declarations no later than 30 March 2008 and, in subsequent years, by the appropriate deadlines". None of the States Parties that had submitted annual declarations for 2011 specified that they were subject to the provisions of subparagraph 2(b).
- 3.5 Subparagraph 2(c) of EC-51/DEC.1 states that "each State Party that has indicated in its initial declaration that it does have declarable activities under any of Parts VI, VII, VIII, and IX of the Verification Annex, but has not provided the relevant annual declarations, [is requested] to submit these declarations no later than 30 March 2008,

Although the submission of "nil declarations" is not a requirement of the Chemical Weapons Convention (hereinafter "the Convention"), a number of States Parties choose to provide the Secretariat with that information voluntarily.

and by the appropriate deadlines in subsequent years". Only one State Party, Swaziland, was subject to this provision and has yet to provide the relevant annual declaration.


- 3.6 Paragraph 4 of EC-51/DEC.1 states that "States Parties that anticipate difficulties in regard to the timely submission of their declarations in accordance with the deadlines in the Convention [are requested] to inform the Secretariat at the earliest possible date of the circumstances of such difficulties". Of the 20 States Parties that submitted at least part of their ADPAs after the deadline (excluding nil declarations), 14 States Parties (70%) submitted information to that effect, thus meeting the requirements specified in this paragraph of the decision. The remaining six did not do so.
- 3.7 Of the 15 States Parties that submitted at least part of their ADAAs after the deadline, (excluding nil declarations), eight States Parties (53%) submitted information to that effect, thus meeting the requirements stated in paragraph 4 of EC-51/DEC.1. The remaining seven did not do so.
- 3.8 Previous Notes issued by the Secretariat (see footnote 1 above) identified five reasons given by States Parties for missing the deadlines for the submission of their declarations:
 - (a) difficulties with drafting and/or obtaining approval for the required legislation or establishing implementation measures;
 - (b) difficulties with identifying declarable activities;
 - (c) difficulties with collecting data;
 - (d) difficulties with preparing declarations; and
 - (e) logistical difficulties in regard to the transmission of declarations to the Secretariat.
- 3.9 Of the 14 States Parties that informed the Secretariat of the circumstances leading to the delays in submission of their ADPAs, 12 cited logistical difficulties (subparagraph 3.8(e) above) and two cited difficulties with collecting data (subparagraph 3.8(c) above) as the reasons for late submissions.
- 3.10 Of the eight States Parties that informed the Secretariat of the circumstances leading to the delays in submission of their ADAAs all cited logistical difficulties (subparagraph 3.8(e) above) as the reason for late submissions.


4. Ongoing efforts to assist States Parties

- 4.1 According to paragraph 3 of EC-51/DEC.1, the States Parties referred to in paragraph 2 of this decision were requested to inform the Secretariat by 30 March 2008 whether they would welcome assistance from the Secretariat in order to meet their obligations.
- 4.2 As mentioned in paragraph 3.6 above, paragraph 4 of EC-51/DEC.1 states that States Parties that anticipate difficulties with submitting their declarations on time are

- requested to inform the Secretariat of that fact and whether they would welcome any assistance in this regard.
- 4.3 During the reporting period, no States Parties requested or indicated that they would welcome assistance from the Secretariat in order to meet their obligations on time.
- 5. Analysis of trends in the timeliness of past ADPAs and ADAAs³
- 5.1 The timeliness of submission of ADPAs from 1997 to 2011 is shown in Figure 1 below.
- 5.2 Although the number of submissions received on time for the first declaration submitted after the approval of EC-51/DEC.1 (ADPA 2007) dropped in comparison to the previous year, for ADPA 2008 there was a significant improvement in the number and percentage of submissions received on time, which was maintained for ADPA 2009 and ADPA 2010. For ADPA 2011, there was a very slight increase in the number of submissions received on time, with 55 (74%) out of 74 States Parties submitting their ADPAs on time, compared to 54 (66%) out of 82 for ADPA 2010.

FIGURE 1: OVERVIEW OF ADPA SUBMISSIONS FROM ADPA 1997 TO ADPA 2011









FIGURE 3: OVERVIEW OF ADAA SUBMISSIONS FOR SCHEDULE 2

- 5.3 The timeliness of submission of ADAAs from 1999 to 2012 is shown in Figures 2 and 3 below.
- 5.4 For ADAA 2012 for Schedule 1 facilities, there was a decrease in the number of States Parties submitting their declarations on time, compared to ADAA 2011. For ADAA 2012, 16 States Parties (73%) with declarable activities submitted their ADAAs on time, compared to 19 States Parties (86%) that did so for ADAA 2011. For Schedule 2 and 3 plant-site declarations, there was a very slight increase in the number of States Parties submitting their ADAA 2012 on time compared to ADAA 2011: 36 States Parties (80%) with declarable activities submitted their declarations on time, compared to 35 (81%) for ADAA 2011.

The numbers and percentages of States Parties in this section do not include submissions of "nil declarations".

FIGURE 2: OVERVIEW OF ADAA SUBMISSIONS FOR SCHEDULE 1 FACILITIES

5.5 Although many States Parties are occasionally one or two days late in submitting their declarations, a number of States Parties are regularly several weeks or months late in submitting them. The number of States Parties that have made annual declarations more than 30 days late since the approval of EC-51/DEC.14 is shown in Figure 4.

FIGURE 4: OVERVIEW OF SUBMISSIONS MORE THAN 30 DAYS LATE




5.6 Since early 2010, the Secretariat has held bilateral meetings with representatives of States Parties that have submitted annual declarations more than 30 days late at least

There have been nine declaration rounds (ADPA 2007, 2008, 2009, 2010, and 2011, plus ADAA 2009, 2010, 2011 and 2012) since the approval of EC-51/DEC.1. Generally, States Parties with no declarable Schedule 1, 2, or 3 facilities only submit ADPAs.

twice since the approval of EC-51/DEC.1. These meetings were held specifically to stress the importance of timely submissions and to offer advice and assistance where needed. During the current reporting period, the Secretariat met with six of the 24 States Parties that fell into this category in regard to the specific issue of the timeliness of submissions. Following these meetings in 2010, 2011, and 2012, 10 States Parties, which fell into the category, submitted ADPA 2011 on time.

5.7 As reported in EC-67/DG.4, there was a significant reduction in the number of States Parties submitting ADPA 2010 more than 30 days late compared to the previous three years. Of the 11 States Parties that submitted ADPA 2010 more than 30 days late, five submitted ADPA 2011 on time, following meetings with the Secretariat concerning late submissions. Up to 31 May 2012, the overall number of States Parties that submitted ADPA 2011 more than 30 days late was six, (see Figure 5). However, more submissions of ADPA 2011 are expected.

5.8 The Secretariat will continue to monitor and report on the timeliness of submissions and to highlight this issue at appropriate regional and bilateral meetings and workshops.
