NOTE BY THE DIRECTOR-GENERAL

LISTS OF APPROVED DATA RECOMMENDED FOR REMOVAL FROM THE OPCW CENTRAL ANALYTICAL DATABASE

- 1. In accordance with a decision by the Executive Council (hereinafter "the Council") at its Fourth Session entitled "Proposed Mechanism for Updating the OPCW Central Analytical Database" (EC-IV/DEC.2, dated 5 September 1997), which was subsequently adopted by the Conference of the States Parties at its Second Session (subparagraph 11.2(c) of C-II/8, dated 5 December 1997), the Director-General established a Validation Group (hereinafter "the Group") to evaluate new data to be proposed for inclusion in that database.
- 2. The Group met for the Fortieth time on 9 and 10 September 2014, and noted that the OPCW Central Analytical Database (OCAD) contained a number of data entries that have been assessed as being redundant, as superior data has been submitted and approved. In accordance with paragraph 8 of the report of the Fortieth meeting of the Group (S/1217/2014, dated 25 September 2014), Table 1 lists the infrared (IR) data, and Table 2 lists the mass spectrometry (MS) data to be removed.
- 3. In accordance with the mechanism (EC-IV/DEC.2) for updating the OCAD, the lists of data recommended for removal will be submitted to the members of the Council and distributed to all States Parties no later than 30 days before the opening of the Seventy-Eighth Session, during which the Council will be requested to consider the data. The Technical Secretariat (hereinafter "the Secretariat"), in the Annex to this Note, hereby submits to the members of the Council and distributes to all States Parties the lists of analytical data whose removal from the OCAD is being recommended.
- 4. The Verification Division will, upon request, make available to States Parties copies of the analytical data listed in the Annex. In accordance with the mechanism referred to in paragraph 1 above, any State Party that has concerns about the recommended removal from the OCAD of any of this data should make them known to the Secretariat before the Seventy-Eighth Session of the Council.
