NOTE BY THE TECHNICAL SECRETARIAT

LEGAL TECHNICAL ASSISTANCE: ROSTER OF MEMBERS OF THE OPCW NETWORK OF LEGAL EXPERTS

- 1. In furtherance of the goals of the Plan of Action regarding the Implementation of Article VII Obligations (C-8/DEC.16, dated 24 October 2003), in May 2003 the Technical Secretariat (hereinafter "the Secretariat") invited States Parties to nominate legal experts who had in-depth knowledge of the national implementing legislation called for by the Convention, and also invited those States Parties that had not yet finished drafting their legislation to submit the names of the drafter or other legal expert who was engaged in this task (S/363/2003, dated 28 May 2003). On the basis of the nominations received in response from 62 States Parties, the OPCW Network of Legal Experts was established, and its first meeting was held at OPCW headquarters in The Hague from 4 to 7 November 2003. The report of that meeting was published in S/398/2004, dated 28 January 2004.
- 2. At present the Network is composed of 89 members from 65 States Parties. Ten legal experts from two international organisations have also been associated with it. The Annex to this Note contains the roster of Network members and associated experts, all of whom may be contacted either directly or through the Secretariat.
